FAQs

Q: How much additional education and/or content is allowed within each sub-page?

A: The content is kept strategically brief for ease of use and readability. We do not offer the ability to add more content. If more content is needed, we recommend storing a separate PDF in the document library.

Q: As the client, how much time commitment is needed on my end?

A: You'll be able to do a thorough review of the site once your company information, branding and benefits are populated.

Q: Can the Web-Guide be password protected?

A: Password protection is not available for the Web-Guide, which is specifically designed to be available outside of company firewalls so it's accessible to spouses as well. For this reason, we recommend avoiding posting any proprietary or company-sensitive information and/or documents to the site.

Q: Can we rename the tiles, categories and/or sub-pages?

A: Absolutely! We want this to be in line with your company culture and how your organization refers to these areas—just let us know!

Q: Can the photos be replaced with our company photos?

A: Yes! You have four opportunities to customize photography within the site if you provide us with high-resolution photos.

Q: Can photos be added?

A: Currently, there is not an option to add photos. If you would like to change the photos to be more in line with your employee demographic, you may either send us photos or we can use royalty-free photos for a \$100 per photo charge.

Q: Can the fonts be changed?

A: Yes. Options are limited to Google Font options. If font changes are necessary, we can provide suggestions.

Q: Can I and/or my team update the Web-Guide on our own?

A: Absolutely! We will hold a "How To" WordPress training session for you and/or your team. Following the session you will be able to:

- Upload new documents
- Remove documents
- Tweak content/make minor updates

You are also entitled to one update from HUB per month, should you require help with more complex updates. These monthly updates are included as part of the \$5,500 annual updates/renewal fee.
